CHANGE OF COMPANY NAMES

The Board is pleased to announce that the English name of the Company has been changed from “Highlight China IoT International Limited” to “Hua Long Jin Kong Company Limited”, and Chinese name of “華隆金控有限公司” as been adopted as the secondary name of the Company in place of “高銳中國物聯網國際有限公司”.

CHANGE OF STOCK SHORT NAMES

References are made to the circular of Hua Long Jin Kong Company Limited (formerly known as Highlight China IoT International Limited) (the “**Company**”) dated 19 October 2017 in relation to, among other things, the proposed change of the Company’s name (the “**Circular**”) and the announcement dated 13 November 2017 in relation to, among other matters, the special resolution passed at the Special General Meeting of the Company held on 13 November 2017 regarding the change of Company’s name. Unless otherwise defined herein, capitalised terms used in this announcement shall have the same meanings as those defined in the Circular.

CHANGE OF COMPANY NAMES

The Board is pleased to announce that the English name of the Company has been changed from “Highlight China IoT International Limited” to “Hua Long Jin Kong Company Limited”, and Chinese name of “華隆金控有限公司” as been adopted as the secondary name of the Company in place of “高銳中國物聯網國際有限公司”.

The Certificate of Incorporation on Change of Name and the Certificate of Second Name were both issued by the Bermuda Registrar of Companies on 27 December 2017. The Certificate of Registration of Alternation of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies on 10 January 2018.
